Meeting was officially called to order by Chairman Hill, at 6:04 pm, April 20, 2021 at 1475 W. American Ave., Oracle, AZ.

Chairman Hill called for a motion to accept the minutes, for the regular and executive meetings on March17, 2021. OFDBM Brown made the motion and Clerk McNulty seconded the motion. All were in favor, motion passed.

Chief Jennings recommended closing the Explorer account at the Pinal County Treasurer's Office, as the program will not be revived again in the near future. All board members agreed with the Chief's decision and that he has the authority to carry this out.
