Chairman Hill called for a motion to accept the previous Fire Board Minutes from March 16, 2022. Clerk McNulty made the motion and OFDBM Brown seconded the motion. All were in favor. Motion passed.

Board Communication Memorandums were provided to each Board member prior to the meeting. These had the beginning and ending balances, income, and expenses, for each bank account and the OFD credit card, for March 2022, compared to the total-year budget and income. Acosta then went over the bank statements and reconciliation reports for each OFD account (General Fund, Volunteer Pension accounts held at the Pinal County Treasurer's Office, the Chase Bank (payroll account), and the National Bank Visa card. Chairman Hill called for a motion to accept the bank statements, reconciliation documents, the balance sheets, and the Memorandum. OFDBM Brown made the motion and Clerk McNulty seconded the motion. All were in favor. Motion passed. Clerk McNulty signed all the financial documents.

Chairman Hill called for a motion to approve signing the Letter of Engagement, which will allow Mr. Benavidez to represent the Oracle Fire District. OFDBM Brown made the motion and Clerk McNulty seconded the motion. All were in favor. Motion passed.
