# ORACLE FIRE DISTRICT BOARD MEETING MINUTES JULY 17, 2019 / Approved AUGUST 14, 2019

Meeting was officially called to order at 6:05 pm, WEDNESDAY, July 17, 2019 at 1475 W. American Ave., Oracle, AZ.

Chairman Brown administered the Oath of office to Paul Arias, who replaces OFDBM Ramsay.

OFDBM Walker made a motion to accept the Pinal County Warrant Resolution adding Paul Arias as a signer. This was seconded by OFDBM Hill. All were in favor. Motion was passed.

OFDMB Hill made a motion to accept the Resolution for the Explorer Fund to approve Chief Jennings and Fire Fighter John Savage as signers for the account. This was seconded by OFDBM Walker. All were in favor. Motion was passed. OFDBM Hill made a motion to accept the Volunteer Firefighter's Pension and Relief Fund approving Fire fighter Harley VanCoillie, and Assistant Chief Brian McGinnis as signers. This was seconded by OFDBM Walker. All were in favor. Motion was passed.

# 7. DISCUSSION AND POSSIBLE ACTION REGARDING UPDATED HR AND/OR BOARD POLICIES

OFDBM Hill made a motion to accept the new Public Safety Personnel Retirement System (PSPRS) Fund Policy as presented by Admin. Manager Acosta. This was seconded by Chairman Brown. All were in favor. Motion was passed.

# 8. DISCUSSION AND POSSIBLE ACTION REGARDING PURCHASE OF NEW TENDER

Chief Jennings presented 3 different quotes for a new water tender to the board. After a discussion, OFDBM Walker made a motion to approve the purchase of a 2019 International Extended Cab water tender for \$230,000.00 (not including the recommended equipment), with a cap of \$300,000.00. This was seconded by OFDBM Arias. All were in favor. Motion was passed.
