The special meeting was officially called to order at 6:06.pm, Wednesday October 19, 2016 at 1475 W. American Ave., Oracle, AZ.

CALL TO ORDER / ROLL CALL:

- 3. THE FIRE BOARD MAY VOTE TO GO INTO EXECUTIVE SESSION FOR DISCUSSION AND POSSIBLE ACTION REGARDING CHIEF SOUTHARD'S UPCOMING RETIREMENT ON DECEMBER 31, 2016. Motion carried.

The Board requested that all applications be submitted to the Admin. Chief / HR. They set a date of Thursday, October 27 at 3pm to review the applications, and of Friday November 4, 2016 at 3pm to hold interviews.
