# 4. ACCEPTANCE OF THE PREVIOUS MINUTES

Chairman Hill called for a motion to accept the October 2021 board minutes. OFDBM Walker made the motion and Clerk McNulty seconded the motion. All were in favor. Motion passed.

# 5. <u>DISCUSSION AND POSSIBLE ACTION REGARDING BUDGET MATTERS,</u> <u>MONTHLY FINANCIAL DOCUMENTS INCLUDING BANK RECONCILIATION</u> <u>AND CASH FLOW PROJECTIONS</u>

Board Communication Memorandums were provided to each Board member prior to the meeting. These had beginning and ending balances, income, and expenses for each bank account and the OFD credit card for October 2021, compared to the total-year budget and income. Acosta then went over the bank statements and reconciliation reports for each OFD account (General Fund, Volunteer Pension accounts held at the Pinal County Treasurer's Office, the Chase Bank (payroll account), and the National Bank Visa card. We have now received our Wildland payments. Chairman Hill called for a motion to accept the bank statements, reconciliation documents, the balance sheets, and the Memorandum. OFDBM Walker made the motion and Clerk McNulty seconded the motion. All were in favor. Motion passed. Clerk McNulty signed all the financial documents.

At the October 2021 Board meeting, OFD Board members requested further clarification from Brenda Tranchina (who wrote the OFD HR Manual and occasionally consults for OFD). This clarification was sent in an email to Chief Jennings, which he read out loud to the OFDBM members. It stated that the current position, working for mechanic Louis Sprott, held by the wife of Chief

Jennings, does not constitute a Conflict of Interest, since she currently does not have any financial interest in Louis's business. However, in the future, should she become part owner of the company, this would give her more power in the financial decisions. Therefore, Chief Jennings would need to disclose this with the OFD Board and the OFD Board would need to review the continuation of using this mechanic's services.

Clerk McNulty made a motion to include this email in the minutes for this meeting and to refer back to it in future discussions, if Chief Jennings's wife's position changes in Louie Sprott's business. OFDBM Walker seconded the motion. All were in favor. The motion passed. All OFDBM members present read and signed the email.
