# 5. <u>DISCUSSION AND POSSIBLE ACTION REGARDING RECENT</u> MODIFICATIONS BY OFD ATTORNEY DONNA AVERSA TO THE PROPOSED ORACLE FIRE BOARD BY-LAWS.

The present members of the OFD Board all felt that the wording by Attorney Aversa (Article III, Section 1, paragraph 3) was too general, and agreed that there should be a reference to the State Statute: ARS 38-481. OFDBM Navarro emphasized that the Board does not deal with employment of firefighters, but only of the Fire Chief. Therefore, the paragraph written by Attorney Aversa is acceptable, as long as the State Statute is added.

OFDBM Doran made a motion to accept the By-Laws as presented, knowing they can edit or change them afterwards. OFDBM Navarro seconded the motion. All were in favor. Motion passed.

OFDBM Doran then made a second motion to add ARS 38-481 to the paragraph written by Attorney Aversa. OFDBM Brown seconded the motion. All were in favor. Motion passed.

OFDBM Brown brought up Article IV, Section 1, which states "...the Clerk who shall keep the minutes of the Board...". Brown made a motion to add ", unless

<u>otherwise delegated by the Board.</u>", just after "…, all correspondence and records of the District,…". OFDBM Navarro seconded the motion. All were in favor. Motion passed.

## 6. ADJOURNMENT.

OFDBM Doran made a motion for the meeting to adjourn. This was seconded by OFDBM Brown. All were in favor. Motion passed.
