New Business:

• Call to the public: Charlotte Poole talked about the upcoming Fire Board election process and she announced that she had mailed in her application to the Elections Department.

Albert gave a progress report for the new awning above the diesel tank. The framing has been completed and the roofing will be scheduled soon.

• We discussed the recent NIMS review from Pinal County Emergency Management. It was agreed that NIMS needed to be added to our SOG's and including our training records. NIMS will also become a regular part of many drills and exercises as well as actual emergency events. Most firefighters have obtained ICS700 but several still need ISC 100, 200 and 800. They will be encouraged to get those classes completed during this month.

• We discussed the recent CERT class that was held during February. Eight new CERT's have joined our team.

• Discussion regarding the Helicopter Landing Zone, repainting and electrical upgrades. A thanks was given to Will for donation the paint. Whyte Electric Company will install the new lighting device that was donated by Lois Briggs.
