## New Business:

- The Arizona Department of Forestry has been awarded a grant for fuel thinning. They currently have funding available to release to the communities of Catalina, Sonoita, and Oracle and they have suggested that we request $\$ 50,000$ to begin with. The Governing Board voted to accept the grant in blocks of $\$ 50,000$ on an as needed basis.
- Four fire trucks that were loaned to the department by Larry and Terrie Southard in 2000 and 2002 have been purchased. Chief Ortiz and Chief Ramsay made an offer of $\$ 60,000$ and the offer was accepted by the Southard's. The vehicles that were purchased include Engine 693, Tender 692, FP-1, and Rescue-1. The Southard's will be removed as lien holders from the titles.
- A new system called FFRS (Fire Fighter Response System) was displayed. The system will provide valuable information to the on-duty crew and to firefighters and CERT's who are responding from home.
- Repairs have been made to the code lights in Rescue 691 . The diesel fill line will be scheduled for a modification that will make it easier to fill with fuel.
- The public restroom remodel project is nearing completion. Jeff volunteered to help finish the plumbing and electrical.
- Chief Ramsay talked about some changes to the Explorer program. A training class will be held for the adult Advisors.
- Call to the public: Doug Johnson talked about the upcoming Thanksgiving Dinner event.
