Chairman Arias requested a motion to accept all the bank statements, reconciliation documents, the balance sheets, and the Memorandum documents as presented for February 2024. OFDBM Walker made the motion. OFDBM Clerk Guyton seconded the motion. All were in favor. Motion passed. Clerk Guyton signed all the financial documents.
